Introduction

Without doing any research, they jump right at it with excitement spending their hard-earned money but as easily as they jumped in so they jump out with disappointment. All these could have been avoided with a business plan.

Writing a business plan is not rocket science, it is simply meticulous planning of your business idea, project, or solution. Several important questions will be answered when you prepare one. Questions like

- **Why do you want to start this business?**
- **Is there anybody out there who will pay for the product?**
- **Will you be profitable selling at the same price as your competitors?**
- **Who are the people you will be working with to achieve your objectives?**
- **How much do you need to start up?**

The list of questions tackled by a business plan is endless. Being able to answer these questions thoroughly shows your level of preparedness.

A good business plan considers and outlines all the expected business challenges and tries to find solutions to them. It is the blueprint or manual for your business. It helps you to stay on track while you are on your way to fulfilling your business purpose.

If you spend time planning your business you will be able to avoid several pitfalls and increase your chances of success.

Malcolm X once said, "The future belongs to those who prepare for it today". Taking out time to write a business plan is the best preparation you can have for your business.

What is a business plan?

A business plan is a roadmap that describes in written detail the objectives of a business and how it intends to achieve them. It entails a company's operational, marketing, and financial goals and strategies.

Why do you need a business plan?

- **So you can realize business projects that work and avoid those that are doomed for disaster.**

All too often, ideas destined for failure are set into motion, leading to wasted time, energy, and money. This can result in disappointment, a loss of self-esteem, strained friendships, and significant financial losses.

Yet it would have been easier if a clear business guide was developed from the beginning.

It is possible to know if your business idea is viable or just an expensive hobby.

- **So You Can Plan Success**

One interesting thing about successful people is that they don't just drift through life but they plan their success. A lot of people have beautiful dreams

and aspirations but how many can create a blueprint on how to achieve them and stick to them?

Business is also like personal success, it can be planned. When your plan is not working all you need to do is to review and adjust accordingly.

A business plan is not written in stone, therefore, should be reviewed periodically to see if it's working and ensure the plan is being followed.

- **To Attract Investors and Raise Funding**

This is the reason most people come up with a business plan; to convince investors or banks to invest in them.

No serious investor will put money into your business without first seeing your business plan. Even if you are not asked for a written document you will be asked to pitch your idea. You would not be able to do this effectively if you haven't given thought to key aspects of the business.

A well-detailed written document will increase your chances of convincing investors to put their money into your hands.

- **To Understand the Market**

The market comprises both customers and competitors. If you are going to build a successful business it's important to find out what your customers want and how you can serve them better than your competitors are already doing.

With a business plan, you will be able to find out your Unique Selling Proposition which will be discussed in the chapter on marketing.

- **To set milestones and make a forecast**

An important superpower every business owner or executive should hope for is the ability to predict the future accurately.

A good business plan is full of numbers, data, milestones, and forecasts all trying to predict the future and show how the business will stay ahead of the game.

It must be quite challenging to remember all that information without forgetting some of it.

With a business plan, you will be able to compare data and make more sense of them so that potential users will appreciate your journey so far in comparison to where you see yourself in the future.

Who Are The Users of a Business Plan?

A business plan can either be used internally or externally.

The company's founder, management team, and employees make up the internal users while banks, investors, lenders, potential partners, suppliers, and customers are external users.

The Cover Page

The cover page is the first page that welcomes potential investors or people who will examine your plan.

Ironically, it is traditionally the last page created when preparing a business plan. It should include key information like the company logo, company name, document title, date of completion, company address, and any other relevant information that gives an overview of the company or business project.

This page should be kept simple and straight to the point. I like to begin to play with the company colors from here. I also like to put a background picture; it could be a picture of the company's residence, product, service, or simply something relatable to the company.

Don't get too worked up about this page as it is just a cover page. Too many activities or content might just put off potential investors. Just use it to introduce

The Table of Contents

The table of contents outlines all titles and subtitles in the plan as the name implies.

This is one of the trickiest aspects for a lot of novice business plan writers as they are not sure what titles a standard business plan should contain.

A good place to start if you hope to write a comprehensive business plan is to use the template offered above in the basic structure of a business plan.

Keep the content simple and well-numbered in chronological order.

The Executive Summary

This is a very important aspect of your business plan. Just like the cover page, it is usually completed after all other aspects of the plan are ready.

The Executive Summary is an overview of the business plan. It takes the reader through your journey so far and your plans for the future.

A standard business plan should contain anywhere between 5 to 30 pages. Potential investors or banks may not want to waste their time reading through a bulky document only to discover the project isn't viable. Reading through a one-page executive summary will tell the reader if the project makes sense.

People who evaluate business plans have prepared many themselves and may have reviewed hundreds of plans so they know precisely what a good summary should contain and which factors determine the success or failure of a business. These are usually simple business-related issues like your

understanding of the target market, your business strategy, or your financial model.

Given that this is your opportunity to make a first impression. I recommend you grab it with both hands. It should be simple, captivating, and concise but detailed. Ensure your data is accurate and there are no spelling or grammatical errors.

Some of the information you should consider putting into your summary is

- Company Name
- Product and services
- The problem
- The solution
- Unique selling proposition
- The market
- Relevant data and financial details
- Your business proposal

As a rule of thumb, it should be 1 or 2 pages long.

Executive Summary (Example)

Introduction Page

The introduction page describes the company, its legal form, what they do, and its vision, mission, ethos, values, and objectives. It should also reflect your story; why the business was started and what it intends to achieve clearly.

When an investor reads the introductory page he/she should have a clear understanding of what the company is about.

This page can have subtitles using some of the elements started earlier i.e.

- (i) Company description
- (ii) Vision statement
- (iii) Mission statement
- (iv) Core values or ethos
- (v) Goals and objectives
- (vi) Company ownership & legal form
- (vii) Critical Success Factors (CSF)
- (viii) Company history and current status
- (ix) Product and services
- (x) Problem
- (xi) Solution

Company Description

A company description is a section of a business plan that provides an overview of the key aspects of a company, including its history, mission statement, products or services offered, target market, management team, and any competitive advantages the company may have.

The purpose of the company description is to give readers a clear understanding of what the company does, why it exists, and how it plans to

achieve its goals. This section should be concise and informative, and it should highlight the unique aspects of the company that set it apart from its competitors.

Vision

Typically, a vision statement is a motivational declaration that articulates an organization's desired future state, specifically outlining where it aims to be in the coming years. It involves expressing, in straightforward, clear, and concise terms, the mental image of the accomplishments you envision your company achieving. When drafting your business's vision, there are fundamental points to consider.

- It should be unique to you. Avoid copying another company's vision statement.
- It should be structured in such a way that all stakeholders of the company can understand and work towards achieving. These stakeholders include employees, customers, suppliers, creditors, etc.
- Keep it simple and concise; one or two sentences should be enough.
- If possible it should reflect the geography of the scope of the market you hope to serve e.g To be Nigeria's ..., to be the world's..., for businesses in Sub-Saharan Africa, etc.
- Make it memorable.

Let's examine the vision statement of Apple Inc.

Apple's vision statement is: **"To make the best products on earth and to leave the world better than we found it".**

Now let's compare Apple's vision with the bullet points I mentioned should be considered when writing a vision statement.

- It is unique to Apple and they have kept it as original as possible.
- It is very relatable, anyone of value to the organization can connect to it

- It is very clear, simple, and concise. The vision statement has been summarized in a statement.
- Their target market is the world, indicating their geographical coverage.
- It is easy to remember.

Mission

A mission statement on the other hand states the reason for the company's existence. It should answer some critical questions including

- (i) What do you do?
- (ii) Who do you do it for?
- (iii) How do you do it?

While the vision looks at the future, the mission looks at the present.

Let's examine Apple's Mission Statement

"To bring the best user experience to our customers through innovative computer hardware, computer software, and services."

Now this brings clarity to how Apple intends to fulfill its vision. It answers the critical questions I listed above

What you do – Innovative computer products and services + amazing user experience

Who you do it for – To Apple's target market (Our customers)

How you do it – Innovation, service delivery & customer experience

Core Values

The core values are the guiding principles, beliefs, or philosophy that dictates the behavior of the company. They reflect the company's culture and ethos. They address areas like who we are and what we stand for.

The core values support the organizational vision, they are timeless and do not change. Examples of core values are Integrity, Ethics, Respect, Commitment, and, Quality.

Goals and Objectives

Goals and objectives are an important part of writing a business plan as they help to define the purpose and direction of the business. Goals are broader, long-term aspirations that a business wants to achieve, while objectives are specific, measurable targets that a business sets to achieve its goals.

The goals of a business plan could include things like

- To establish a new business or expand an existing one
- To introduce a new product or service
- To increase market share or profitability
- To establish a brand or market presence
- To enter a new market or expand geographically

Objectives are the specific steps that a business will take to achieve its goals.

These could include things like

- To achieve a specific sales target within a certain time frame
- To increase the number of customers by a certain percentage
- To launch a new product or service within a certain time frame
- To increase profitability by a certain amount
- To establish a strong online presence through social media and digital marketing efforts

By setting specific goals and objectives, a business can create a roadmap for success and ensure that everyone within the organization is working towards the same objectives. This can also help to measure progress and make adjustments to strategies if necessary.

Company Ownership and Legal Form

In writing a business plan, the section for company ownership refers to the legal structure of a business and the ownership of its assets. It describes who owns the business, how ownership is divided, and how ownership will change over time.

The ownership structure of a company can take many forms, including sole proprietorship, partnership, limited liability company (LLC), and corporation. In a sole proprietorship, one individual owns and manages the business. In a partnership, two or more individuals own and manage the business together. In an LLC, the owners (referred to as members) have limited liability and the business is treated as a separate legal entity. In a corporation, the owners (referred to as shareholders) have limited liability and the business is treated as a separate legal entity.

In a business plan, it's important to clearly outline the ownership structure of the company and how ownership will be divided among the owners. This information helps investors and stakeholders understand who has control over the business, how decisions will be made, and how profits will be distributed. It's also important to address any potential changes in ownership, such as the addition or departure of owners or the sale of the business. Investors will be interested in your business's legal form because it determines the cost, tax, legal, regulatory, and financial risk implications.

Critical Success Factors (CSF)

Critical success factors (CSFs) are the key variables that determine the success of a business plan. They are the crucial areas that must be

addressed for a company to achieve its objectives and goals. Here are some examples of CSFs that should be considered when creating a business plan:

1. **Market demand:** The company must have a clear understanding of its target market and the demand for its products or services. This requires market research to determine what the target audience needs and wants, as well as the competitive landscape.
2. **Financial stability:** The company must have a solid financial plan in place, including a realistic budget, revenue projections, and an understanding of cash flow. This helps to ensure that the company has the financial resources necessary to sustain operations and grow over time.

Unique Selling Feature

The Unique Selling Point is an interception between what your customers want and what you do well.

The Unique Selling Point (USP) is the characteristic that sets a product or service apart from its competitors in the market. In a business plan, the USP is an important element as it highlights the competitive advantage of the product or service, and explains why customers would choose it over alternatives.

The USP could be based on the product features, quality, price, customer service, or any other factor that differentiates it from the competition.

The USP should be clearly stated in the business plan to convey the value proposition to potential investors, partners, or customers. It should be easy to understand, memorable, and persuasive, and should be backed up by evidence, such as customer testimonials, market research data, or sales figures. A strong USP can help a business to gain a competitive edge and increase its chances of success in the market.

The problem

It's important to create a product that solves a problem. Most viable ideas are problem-centric (approaching a situation by thinking critically about how to solve it).

The problem that a business plan aims to address is typically some kind of gap or need in the market that the company aims to fill. This could be a lack of certain products or services, an inefficient or outdated business model, or a need for innovation in a particular industry.

Talk about the problem you are trying to solve, who it affects, and how it affects them. A good place to start is the SDG goals. All the world's problems are summarized in the goals and a lot of investors specifically invest only in projects tackling at least one goal.

The Solution

You should also detail concisely how you intend to solve the problem. This could be through your product, marketing, pricing, or other means.

Be innovative and original. You don't necessarily have to do something nobody has ever done before to be innovative. You can transfer technology from other fields or simply meet a need in a more efficient way.

The solutions presented in a business plan are the strategies and tactics that the company intends to use to address the identified problem or need. These solutions should be based on a thorough analysis of the market, the competition, and the company's strengths and weaknesses. They should also be realistic and feasible, taking into account factors such as budget, resources, and time constraints.

Some possible solutions that can be proposed in a business plan are:

- Developing new products or services to address unfulfilled market needs.
- Improving existing products or services to enhance competitiveness.
- Adopting new technologies or processes to increase efficiency and cut costs.
- Expanding into new markets or territories to boost revenue.
- Partnering with other businesses to leverage their strengths and capabilities.
- Investing in marketing and advertising to improve brand awareness and attract customers.

The recommended solutions should be customized to fit the company's particular needs and objectives and should be aimed at positioning the company for sustained success and growth.

This is easier said than done. A lot of zealous entrepreneurs already have a mental picture of what they want and are always likely to interpret the results to correspond with their opinions.

If you want objective research I recommend you allow external experts with no interest in the result to research for you.

- Evaluation of results
- Interpretation.

Milestones in project management are an effective tool used to evaluate and monitor progress. Without milestones, it would be difficult to track progress, making the business owner less accountable.

Investors are always interested in milestones because it tells them the entrepreneur's grasp of what it takes to meet up the business goals and objectives.

Milestones should be set thoughtfully and through research. If possible, discuss with your team to map out in detail what you need to meet your business goals and objectives.

You can also indicate your current milestones and next milestone. State what you have achieved so far and the ones you hope to do soon.

Examples of milestones are product launch, licensing, and registration, increase in revenue, cutting of cost, and employee turnover.

Timelines

Project timelines indicate the project start and completion date. This is another project management tool that goes hand in hand with the project milestones.

Several project management tools can be used to effectively and concisely summarize your project plan. I always recommend the Gantt Chart because they help in planning and scheduling projects in such a way that you can easily keep track of progress.

Project Objectives (Example)

Financial Plan

A Financial plan is a company's current financial position and a roadmap of how it intends to achieve its financial objectives. This is usually the most difficult part of writing a business plan for most people because of the challenges of adding up the numbers.

Interestingly, you don't need to be an accountant or have an MBA to plan your business finances. If you study financial statements and ratios closely you will see that it's just a simple logical but holistic process. Even the financial jargons are quite easy to comprehend.

There are several reasons why a financial plan is important when preparing a business plan.

- It tells you whether you are making a profit or a loss. This is very important because the primary reason people go into business is to make a profit but most entrepreneurs aren't able to accurately tell if they are or not.

- It helps you to make educated business and investment decisions. A good understanding of your financial position will help you decide which alternative is best for the business. An example, if you anticipate that a machine will depreciate and lose its value over five years, you will be able to plan better to replace it.
- It serves as a financial guide. Business can be very dynamic but also predictable. Your financial plan should be structured in such a way as to project the future. These projections can guide you in your business journey.
- It tells you what you own as a business organization. Some components of a financial plan which we will discuss next can tell you what you own or owe. This is very important as the valuation of your assets will tell the worth of the company should you consider mergers and acquisitions.
- It is a requirement by most investors. Investors always ask for a financial plan. A well-prepared financial plan has a better chance of acquiring investors.

A good financial plan for a business will include revenue, expenses, cost, profit, assets, liabilities, cash flow, and financial ratios.

There are certain components a professional financial plan should have. These include

1. Profit and loss statement
2. Balance sheet
3. Cash flow statement
4. Break-even analysis and business ratios
5. Sales projections
6. Financial strategy

1. Profit and loss statement

The P&L statement also known as the income statement is a summary of the sales revenue and expenditure over some time.

The P&L account aims to show if you are making a profit or a loss and show what expenses are influencing your business the most. There are certain terminologies you have to get used to when +making a P&L statement

- **Sales revenue:** Income that comes into the company from business activities.
- **Cost of sales:** Expenses that can be linked directly with production and selling. Examples are direct labor and the cost of raw materials. They do not include costs like administrative, general expenses, interest expenses, and depreciation.
- **Gross profit:** Sales revenue less Cost of Sales. It is the profit earned after a company has deducted all costs incurred that are directly associated with production and selling. It doesn't include overheads.
- **Expenses:** Costs incurred during a company's business activities.
- **Overheads:** These are costs that are related to running the business. They cannot be traced directly to production or selling but are important for the smooth running of the business examples are utilities, rent, advertising, communication, consulting, depreciation e.t.c.
- **Depreciation:** Depreciation is the loss in value of tangible assets due to wear and tear. E.g Machines, cars, equipment

- **Amortization:** What depreciation is to tangible assets amortization is to intangible assets. It's the gradual writing off of intangible assets over their useful life. Examples of things that can be amortized include licenses, copyrights, patents, and registrations.
- **Net Profit:** Net profit is profit after all expenses have been subtracted from the revenue in other words it is gross profit less general cost, administrative cost, overheads, and depreciation
- **Profit after Tax:** This is net profit less tax.

2. Balance sheet

The balance sheet is a snapshot of a company at a particular point in time. The key features of a balance sheet are assets, equity, and liability.

Assets: Assets are what a company owns. They can be divided into two

- **Current Assets:** Assets that are expected to be expended within 1 year. They will be sold or used up within 1 business year. Examples include cash and cash equivalent, stock, raw materials, accounts receivable, prepaid liabilities, and marketable securities.
- **Fixed Assets:** fixed assets are assets that have a useful life of more than 1 year. These are non-current assets. An example includes machines, vehicles, land, properties, long-term investments, and shares.

Equity: Is the owner's investment in the business

Liability: Liability is what the company owes

Current liabilities: These are debts the company owes that are due within 1 business year. E.g Accounts payable, short-term debts, dividends.

Non-current liabilities: These are debts or financial obligations the company has to pay its creditors that are due after 1 business year. E.g Long-term debts, debentures, long-term lease obligations, bonds payable, and deferred tax liabilities.

3. Cash Flow Statement

A cash flow statement is a financial statement that summarizes the inflow and outflow of cash and its equivalent in an organization over a period of time.

The cash flow statement is divided into three parts

- Operating activities
- Investing activities
- Financing activities

1. Cash flow from operating activities: This is the first segment of a cash flow statement and it indicates the inflow and outflow of money into the company through its regular business activities. This may include buying and selling, manufacturing, and offering services.

2. Cash flow from investing activities: This is the inflow and outflow of cash into a company through investment-related activities. Investment activities include purchases and sales of physical assets, investments in marketable assets like bonds and shares, and the acquisition of other businesses.

3. Cash flow from financing activities: This is the net cash flow in a company that reflects how a company is funded. Examples of financing activities are loans from banks, repayment of bank loans, issuance of bonds, and payment of dividends.

4. Break-even analysis and business ratios

Break-even analysis entails calculating and assessing the margin of safety for a business. With break-even analysis, you get a better understanding of

the number of sales the company needs to make to pay all its costs. After a company breaks even then any additional sales made begin to contribute towards profit.

The key parameters for calculating break-even are sales, unit price, variable cost, and fixed cost.

- Unit price: This is the price of selling a single product, service, or package.
- Variable costs: These are costs that change with volume or sales. They are dependent on the quantity of the goods or services that a business produces. Examples of variable costs are raw material cost, delivery costs, packaging cost, and direct labor.
- Fixed cost: Fixed costs are costs that remain the same and are independent of sales or volume. Examples of fixed cost include rent, fixed salaries, loan repayment. Utilities, and insurance.
- Gross margin: This is total sales less cost of goods sold or cost of sales.
- Cost of goods sold: This is the direct cost of producing or offering a business service.

Calculations for Break-Even Analysis

The calculation of break-even analysis may use two equations. In the first calculation to evaluate the number of units needed

Break-Even Point (units) = Fixed Costs ÷ (Sales price per unit – Variable costs per unit)

Alternatively, the calculation for a break-even sales happens by dividing the total fixed costs by the contribution margin ratio. The contribution margin ratio is the contribution margin per unit divided by the sale price.

Assume a company that produces bread incurs the following costs to produce one unit of their special butter bread which they sell at \$25.

Flour – \$6, Butter – \$2, Egg – \$1, Other direct cost – \$3. Note that they were able to calculate these costs by dividing the amount spent on each item by the total number of units they were able to produce.

Break Even Analysis (Example)

Assuming that Dream Puff has fixed costs of \$50,000 per year and a contribution margin of 60% on each product sold, the breakeven point can be calculated as follows:

Breakeven point = Fixed costs / Contribution margin ratio

Breakeven point = \$50,000 / 0.6

Breakeven point = \$83,333.33

This means that Dream Puff needs to generate at least \$83,333.33 in revenue each year to cover its fixed costs and break even. Anything above this amount will result in a profit for the business.

Sales Projections

Sales projection is an estimate of the revenue a business expects to generate over a certain period, typically a year. It is an essential component of a business plan as it helps business owners and investors to understand the financial viability and potential profitability of the business.

Sales projections take into account various factors such as market demand, pricing strategy, competition, marketing initiatives, and growth opportunities. They provide a framework for businesses to set realistic goals, plan for

resources, and make informed decisions about investments and expenditures.

Financial Strategy

Financial strategy (Example)
